I accept full responsibility for any and all damages or thefts that occur during my rental for all members involved in my event. I agree that if any persons are added during the trip, who are NOT a part of the original group, it will be at the discretion of the Contracted Person/Driver ONLY (not to exceed capacity limits for bus. NO STANDEES.) I have the right to inspect the Lakes Area Party Ride bus prior to my trip and report and noticed damage. I have accepted Lakes Area Party Ride bus in good faith and agree to the above listed price. I agree to pay for all services rendered at the time of pick-up, and any additional hours at the trips end. I will extend these rules to persons of my group or any added persons during the trip.

Rules and Regulations for Lakes Area Party Ride LLC:

- We accept Cash or any major Credit Card (*There will be a 5% surcharge on any credit card transactions, proper ID required as well*). All funds will be collected upon arrival, before the event will start.
- Cancellation/Damage Deposit Policy: There will be a \$250 damage deposit required at the time of booking to reserve the bus for your event (Cash, Check or Credit Card). In the event you cancel the booking the \$250 is non-refundable. If cancelled within 14 days prior to your event you will be responsible for 100% of the rate charged if Lakes Area Party Ride is unable to re-book your date. If no damages are noted after your event (*broken windows, damage to seats, excessive mess, etc.*) your damage deposit will be refunded back on to your credit card or check within 2-3 weeks after your event. You are welcome to inspect the bus before your event to note any flaws and address them with the driver.
- Any actions such as harassment, fighting, and/or violence towards the driver, staff or anyone else in or around the Lakes Area Party Ride bus; the driver reserves the right to terminate trip. The Client will forfeit the full fare and be responsible in finding alternate transportation. Damage to equipment and/or bus falls under the same parameters and will be at the discretion of the driver.
- Lakes Area Party Ride LLC is not responsible for injuries or accidents in and around the bus. Alcohol impairs motor skills, balance and judgement. Clients are to be REMAIN SEATED while the bus is in motion. Move around at your own risk and use caution when entering and leaving the bus, floors/steps may become wet and slippery during your event.
- Alcoholic beverages are not allowed off of the bus.
- There is No Smoking or Vaping allowed on the bus.
- Any illegal drug use or drug paraphernalia found or used on or by the Lakes Area Party Ride bus is terms for termination of event and law enforcement may be contacted.
- NO underage drinking is allowed. If the driver suspects minors are consuming alcohol, they will be asked to get off of the bus and find their own transportation. The driver also reserves the right to contact law enforcement for underage drinking as well.
- By signing this contract, the above client agrees to assume full responsibility for any and all damages, items removed or stolen from Lakes Area party Ride bus and/or personal property of members of their group. All damages assessed will be charged at \$30/hour labor plus replacement parts.
- In the event of a passenger vomiting in or on the Lakes Area Party Ride bus there will be a minimum charge of \$150 per incident. (Payable to driver promptly.) The client and passenger/s will be supplied with basic cleaning supplies to clean up vomit immediately once the bus has safely stopped.
- Excessive Cleaning will also be at the rate of \$30/hour, retained from your damage deposit. Jell-O Shots, red wine and food are not recommended on the Lakes Area Party Ride bus. These may result in excessive cleaning charges or damages if stained on seats or floor.
- Lakes Area Party Ride LLC is NOT LIABLE in cases of unexpected vehicle break downs, accidents, severe weather or anything that may delay a timely arrival or cause of cancelation of trip. In the event of a cancellation due to mechanical or "No Travel Advisory," the trip may be rescheduled for another date if possible or refund may be given at the discretion of Lakes Area Party Ride. Client will be notified as soon as possible to let them know of mechanical problems or adverse weather that may postpone trip times. Your safety is our priority!
- In the event of mechanical failure or accident during the event, Lakes Area Party Ride LLC will try to arrange other transportation. If unsuccessful, the client will be responsible for finding transportation for all members of their party, and a pro-rated refund will be given on a case-by-case situations.
- Lakes Area Party Ride LLC and their drivers hold the final decision for any and all conflicts to this contract addressed above.
- Quotes given by Lakes Area Party Ride may include a fuel surcharge on top of provided quote based on MN average price of Diesel on the day of your event. (*\$50 surcharge if over \$4.75/gallon or \$100 if over \$5.50/gal.*)
- Lakes Area Party Ride drivers are well qualified, properly licensed and trained to give you the best experience for your event. Please treat them with the upmost respect.
